

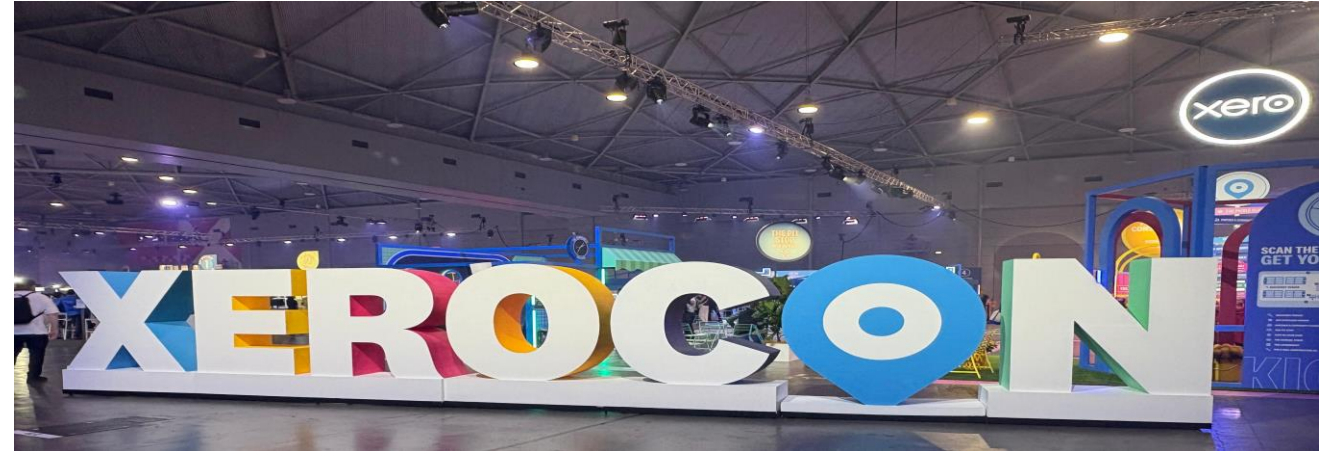
GLOBAL ECONOMIC FORUM - MUMBAI

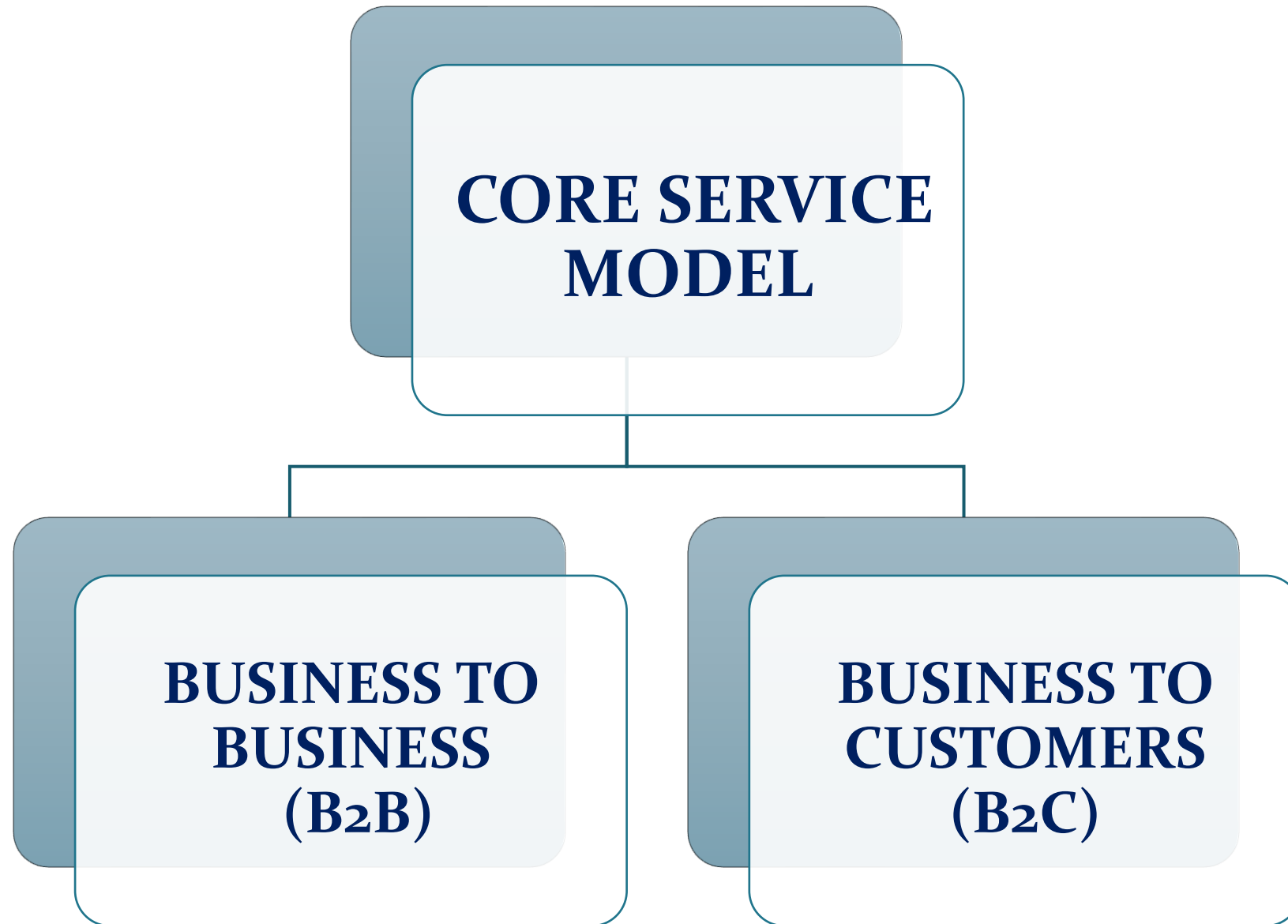

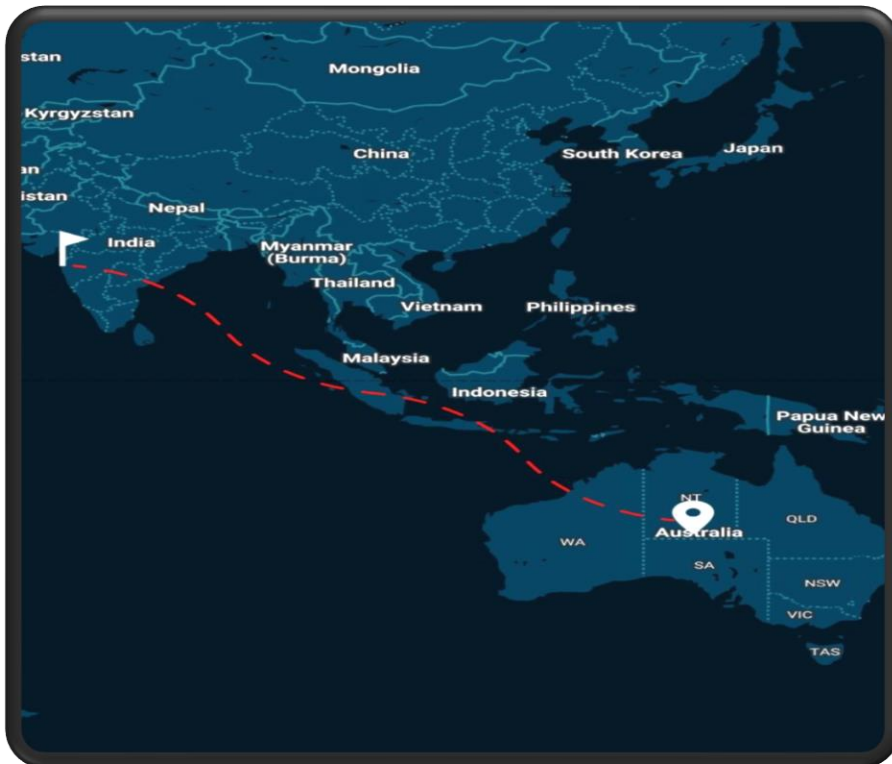

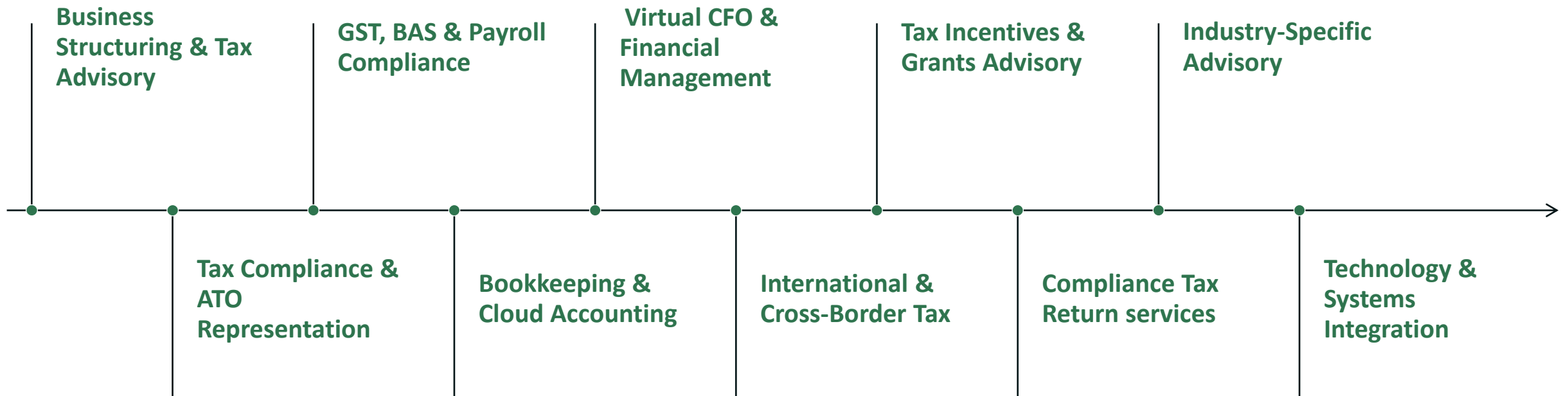
